

## WONDERLIGHTS TICKET GIVEAWAY

### SPONSORED BY WORLD WIDE TECHNOLOGY RACEWAY

#### OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**

2. **Eligibility.** Subject to the additional restrictions below, the “**WonderLights ticket Giveaway**” (the “Sweepstakes”) is open to legal U.S. residents (excluding Puerto Rico) who live in the KSDK-TV viewing area and are 18 years or older at the time of entry. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn’t interfere with processing your entry.
