

# VACATION LIKE A NINJA SWEEPSTAKES

## SPONSORED BY EXPLORE ST. LOUIS

### OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**

2. **Eligibility.** Subject to the additional restrictions below, the “**Vacation Like a Ninja Sweepstakes**” (the “Sweepstakes”) is open to legal U.S. residents (excluding Puerto Rico) who live in the KSDK-TV viewing area and are 18 years or older at the time of entry. Employees and contractors of Explore St. Louis, (“Sponsor”), TEGNA Inc., and each of their respective affiliated companies, and advertising and promotional agencies, and the immediate family members of, and any persons domiciled with, any such employees or contractors, are not eligible to enter or to win.

3. **How to Enter.** Enter by watching Today in St. Louis from 5 a.m. – 7 a.m. Monday, Aug. 31, 2020 through Friday, Sept. 4, 2020. Look for the code word each morning, then visit the Contests tile on the KSDK app or go to [ksdk.com/contests](https://ksdk.com/contests). Fill in the code word, complete the entry form, and follow all posted instructions. The Sweepstakes will begin at 5 a.m. (C.D.T.) on Aug. 31 and close each day at 3 p.m. (C.D.T.) until the conclusion on Sept. 4 (the “Sweepstakes Period”). Entries limited to only one (1) entry per person per day. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn’t interfere with processing your entry.

Multiple entrants are not permitted to share the same email address. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries. By entering, you agree to the terms of these Official Rules and to receive e-mails from Sponsor, Administrator or those directed by Sponsor or Administrator. You can opt-out of the receipt of such e-mails by following the directions in any email received from Sponsor.

4. **Winner Selection.** One (1) Grand Prize Winner will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period.

5. **Prizes and Odds.** One (1) Grand Prize Winner will take home a “Vacation Like a Ninja” prize pack, which includes: A suite for four (4) at the Marriott Grand Hotel in Downtown St. Louis, four (4) passes to the Rope Course at St. Louis Union Station, four (4) passes to Climb So iLL rock climbing gym, four (4) passes to Go Ape Zipline & Adventure Course, and four (4) passes to Amp Up Action Park.

The prizes must be redeemed by Sept. 7, 2021. **ARV: \$852.**

Odds of winning depend on the number of eligible entries received.

Winners acknowledge that each member of their party must follow all health guidelines implemented by the prize locations.

**6. Winner Notification and Acceptance.** Winners will be notified on or after Friday, Sept. 4, 2020 by email. The winner must respond to such notification within 72 hours. Failure of winner to respond with such time period or return of email prize notification as undeliverable may result in disqualification and an alternate winner may be selected from among all remaining eligible entries. To claim prize, each winner must work with Explore St. Louis to receive passes and make any necessary arrangements. Winners may waive their right to receive prizes. Prizes are nonassignable and nontransferable. No substitutions allowed by winner. Prizes are not redeemable for cash. Prizes and individual components of prize packages are subject to availability and Sponsor reserves the right to substitute prizes of equal or greater value. Winners are solely responsible for reporting and payment of any taxes on prizes. Winners may be required to complete an affidavit of eligibility/liability and publicity release (except where prohibited by law) which must be returned as instructed by Sponsor. Should the Sweepstakes be terminated prior to the stated expiration date, Sponsor reserves the right to award prizes based on the entries received before the termination date. Sponsor will not be responsible for incomplete, lost, late, postage-due, misdirected or illegible entries, or for failure to receive entries or votes or other electronic communications due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor. In the event of a dispute, all online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent.
